SUBJECT: Amend Master IGA to add NAIPTA to Executive Board

1. Recommendation:

Staff recommends the Board request an amendment to the FMPO Master IGA between the City of Flagstaff and Coconino County to add NAIPTA to the FMPO Executive Board with the following language: "One (1) member appointed by the NAIPTA Board of Directors who is not a member of the Flagstaff City Council or County Board of Supervisors".

2. Related Strategic Workplan Item

FMPO Guiding Principle: FMPO is fair and equally representative

3. Background

- On September 18, 2018 an IGA was recorded between the City of Flagstaff and Coconino County establishing the FMPO as a separate legal entity and empowering an Executive Board as the policy making body. Section 3.2 of the IGA established the Executive Board with the following voting members:
 - Three (3) members of the Flagstaff City Council
 - Two (2) members of the Coconino County Board of Supervisors
 - One (1) representative from the Arizona Department of Transportation

On October 2, 2019 the FMPO considered a request from the Northern Arizona Intergovernmental Public Transportation Authority (NAIPTA) to join the FMPO Executive Board and gave preliminary direction to staff to use the following language: "One (1) member of the NAIPTA Board of Directors who is not a member of the Flagstaff City Council or County Board of Supervisors"



This language provides a seat for a member of NAIPTA's Board of Directors on the FMPO Executive Board and does not create a quorum of the City Council or County Board of Supervisors on the FMPO Executive Board.

On November 4, 2019 the FMPO Board discussed variations to language and the possibility of adding flexibility so that NAIPTA could appoint the NAIPTA CEO to the FMPO Executive Board.

On November 20, 2019 the NAIPTA Board of Directors passed a motion recommending the following language. "One (1) member appointed by the NAIPTA Board of Directors who is not a member of the Flagstaff City Council or County Board of Supervisors". This language allows NAIPTA to appoint a Board member or staff to the FMPO Executive Board and does not create a quorum of the City Council or County Board of Supervisors on the FMPO Executive Board.

In order to amend the Master IGA, staff suggest a letter be signed by the FMPO Board Chair and sent to the City and County requesting specific amended language. Specific language is provided in the alternatives section of this staff report.

4. TAC and Management Committee Discussion

Due to schedule conflicts the November Management Committee meeting was cancelled, and this item was not discussed with the TAC. However, this report was shared with Management Committee members prior to the December 4th and January 8th meetings and feedback was invited.

5. Fiscal Impact

i If NAIPTA is added to the Executive Board NAIPTA would pay \$5,000 per year membership dues.

6. Alternatives

The key question is whether to establish NAIPTA's appointment as a member of the NAIPTA Board of Directors, similar to the City and County arrangement, or to allow the appointment of NAIPTA staff, similar to the ADOT arrangement. Both alternatives are viable and the differences are nuanced.



1) Use language parallel to that used for ADOT which allows the appointment of NAIPTA staff (recommended).

"One (1) member appointed by the NAIPTA Board of Directors who is not a member of the Flagstaff City Council or County Board of Supervisors".

This language was requested by the NAIPTA Board on November 20, 2019 and does not create a quorum of the City or County on the FMPO Board.

This alternative provides more flexibility to NAIPTA because it allows the appointment of staff. This alternative provides a similar relationship to ADOT because it allows staff to serve on the FMPO policy board. A case could be made that a more open structure and maintaining structural equity with ADOT is appropriate.

2) Use language parallel to that used for the City and County which appoints a member of the policy board. Specifically, the City and County are required to appoint a member of City Council or the Board of Supervisors. Parallel language to the City and County would be as follows:

"One (1) member of the NAIPTA Board of Directors who is not a member of the Flagstaff City Council or County Board of Supervisors".

This alternative provides less flexibility to NAIPTA because it requires a member of the NAIPTA policy board. This alternative provides a similar relationship to the City and County because members of the City and County policy body, rather than the City or County Manager, serve on the FMPO policy board. A case could be made that maintaining a policy body structure and structural equity with the City and County is appropriate.

3) Table discussion. Not recommended. Both organizations have considered this question extensively over the past 10 months and two viable options are available that allow us to move forward.

Mr. Clifton and Mr. Jayne:

The FMPO would like to add the Northern Arizona Intergovernmental Public Transportation Authority (NAIPTA) to the FMPO Executive Board and is requesting an amendment to the IGA the City and County recorded on October 3rd, 2018.

The requested amendment is to section 3.2 which states: "The FMPO will be governed by an Executive Board that will consist of the following voting members:

- Three (3) members of the Flagstaff City Council
- Two (2) members of the Coconino County Board of Supervisors
- One (1) representative from the Arizona Department of Transportation"

We request a fourth bullet be added to section 3.2 that states:

 One (1) member appointed by the NAIPTA Board of Directors who is not a member of the Flagstaff City Council or County Board of Supervisors.

This language will prevent the creation of a quorum of the City Council or Board of Supervisors on the FMPO Board while providing for voting representation from the NAIPTA Board.

Staff has confirmed availability with Executive Board assistants to confirm meeting dates, eliminating the March, July, August, and November meetings to accommodate Executive Board conflicts.
